PAYMENT POLICY

- Your account must be current and up-to-date with payments totaling \$800.00 (4 payments of \$200.00 each) by **November 27, 2019**, or your reservation will not be included on the hotel room list.
- **The final balance is due by February 1, 2020.** If your final balance has not been received by **February 1, 2020**, your reservation will be canceled. No refunds will be issued.
- A 3% late charge will be assessed on amounts due after each payment due date.
- A \$45.00 service fee will be charged for checks returned because of insufficient funds.

CANCELLATION POLICY

- All cancellations must be made in writing to Noteworthy Tours. The cancellation date will be determined by the postmark or email date.
- **The initial \$200.00 deposit is non-refundable.**
- **Prior to November 28, 2019**, a refund less the initial non-refundable \$200.00 deposit, and less any non-refundable items, including, but not limited to, airfare, theater or concert tickets, vendor deposits, admissions, etc., will be issued.
- **On or after November 28, 2019**, a refund less the initial non-refundable \$200.00 deposit and less a \$200.00 cancellation fee, and less any non-refundable items, including, but not limited to, airfare, theater or concert tickets, vendor deposits, admissions, etc., will be issued.
- **On or after December 19, 2019**, no refunds will be issued for cancellations received.
- Refunds will be applied to your credit card or issued by company check and mailed within 30 days of refund approval.
