Regular Monthly Meeting Minutes

Tuesday, May 12, 2020

The meeting was called to order at 6:33 by booster president Sheri Gestring, 2nd by Tony Oslejsek.

Public Comments: none

I. Treasurer Report: Dawn McColloch, Assistant Treasurer: Denise Gentile

A. Malley's online sales \$270.09

C. Denise asked if all money is out of the building. Mr. Ciulla will check the lockbox tomorrow as this is the first time he has been allowed back in the building.

D. Denise mentioned she will need to turn over stamp to the new assistant treasure. Sheri G. said she would meet with her or Mr. Ciulla and said she could drop it off at the school to be placed in his mailbox.

II. Director Report (Vicent Ciulla)

A. Disney - It was a tough decision but after the governor's orders and the school being closed, Mr. Ciulla had to make the decision to postpone the trip until next year, March 19-24, 2021. He has a new contract that he will be signing. He is working on refunds with the tour company for the people that will not be able to travel next year with it being mostly senior students

at this time. He is also working and reaching out with other directors to get ideas as well. Sheri G. will be checking with insurance policies to see if there is anything we could do to help our senior families. Mr. Ciulla will give Sheri G. a number of students and the total dollar amount the students spent that are not able to travel. Due to unprecedented conditions, back and forth discussions regarding the appropriate method to provide refunds will be provided as soon as more information is available. Mr. Ciulla just wants everyone to know that he is doing everything he can to help people that were not able to travel with the band due to these unfortunate events. After signing the new contract with Noteworthy he will have information to give out to the new students who register for next years trip.

- B. Senior Students** - Mr. Ciulla would like to do something nice for them since they were not able to go on the trip and other events that happened during their senior year. He spoke on how he was pleased how his colleagues were doing events for the senior class. He wanted to possibly offer maybe going to a restaurant, spotlight a senior, or any other ideas that anyone can come up. Tony said that he would love to see anything as a senior parent, he will talk to Maci and friends, Denise will talk to Benny and friends. Sheri mentioned doing a google form, Mr. Ciulla said he would create and send it out, to see what the seniors might want. Mrs. Logan suggested if we go the gift card route that we try and make it something they could use towards college or their future.

When asked if there would be a contract for the new students regarding the sousaphones, Mr. Ciulla confirmed.
