C. Mrs. Logan and Ms. Kois discussed size of classes and interested in bands coming up from younger grades. It is hard to see true numbers because of Covid but it does look like the band will be growing.

II. Director Report (Ms. Kois)

A. State of the Bands

- a. Defer - doing good just not getting to see much because of testing
- b. High School - doing good having great rehearsals
- c. Jazz Band - doing great, 4 songs being prepared and new drummer for jazz band has been recruited due to concert band percussion not wanting to play drums in jazz band.

B. Uniforms approved and money from district has been tentatively put in place but may still need to use prior approved funds from band boosters, the uniforms have been picked up. Larry picked up last Thursday and will bring them back to the school.

C. Mallets are needed and Ms. Kois will need to spend about \$400 out of the directors fund. Sheri G. confirmed that according to the bylaws anything over \$200 has to have approval. Laura suggested sending out an email for approval, Sheri G. agreed that an email would be fine.

D. Graduation will be on May 25th with a rain day of May 26th., Mr. McCann is out on leave but Ms. Kois will be working with Mrs. Taylor for more details

 - d. 7th grade band is going well with some students able to join again
 - e. Not getting to see the 8th grade during the 4th quarter
- C. Would like to start after school lessons next year to help students that did not get to join band and that should help bring numbers up.
- D. Sheri G. also wanted to make sure that auxiliary knows they are invited to the bowling event. Would like to invite 8th graders to bowling event (all agreed). Mrs. Logan will make sure 8th graders get the invite. Sheri G. just needs to get a number to the bowling alley by the end of next week. Ms. Kois confirmed that Mr. McCann said we do not need permission slips for bowling since it is not a school sponsored event.


